#### Water Plant Supervisor Report, Brian Bush

Mr. Bush reports 11.1 million gallons of water produced, 6.4 million gallons sold, 4 million gallons sold to Woodaway Water, 18 hours of average pump time,, and water loss at 43%. Mr. Bush was questioned about the water loss and the amount of overtime being worked. He stated the demand for water was creating the overtime. The Council instructed Brian to adjust the work schedule by creating a 2-3 hour gap between shifts in the afternoon. He stated he would do so.

#### Police Report, Chief Terry Sivert

Chief Sivert reports 5795 miles patrolled, no maintenance on any cars. Eight traffic citations written. 79 calls answered, 10 motorists assisted with lockouts, 10arrest (2 Probation Violation, 1 DUID, 1 Refusal, 3 PB-15, 4 Capias). Fines Assessed/Collected: Continued to January 2018 and Paid Fines \$277.38. Annual report for 2017 are as follows: 56,880 patrol miles, 181 traffic citations, 144 calls answered, 131 assist motorists with lockouts, 28 reportable accidents, 6 non-reportable accidents, 131 IBR reportable incidents, 133 arrests, assessed fines-\$11,394 and collected fines \$4,460.98. JPD assisted County on various calls. Helped citizens in obtaining warrants and orders from magistrate. Assisted fire and rescue with calls. Provided routine escorts IGA, Shubert's and Lee Food Mart. Assisted Sheriff's Office with funeral escorts in town. Halloween was successful with extra patrols and candy handed out to the children. Additional patrols will be added for the holiday season.

# **Town Superintendent Report, Jimmy Cluesman**

Mr. Cluesman reports no disconnects, no sewer issues, Andrew Selph customer on Town Branch has been having issues with frozen water due to it freezing on the town's side. One thousand feet of water line has been laid to try and help resolve the situation. Mr. Selph asked since he had so much expense with having to purchase water if the council would relieve his water bills for December and January. The water meter has been pulled and is not being metered. Bobby Slusher made the motion to relieve Andrew Selph's water bills for December and January; seconded by Tommy Livesay. All in favor, motion carries. Mr. Cluesman ask if running boards can be installed on the new F250 that was purchased. All was in agreement. He also purchased a heater for jobs when they are outside and its cold and is is extremely cold.

The heat pump in the Town Hall is also not working properly, it was looked at they feel it needs to be replaced since it is 27 years old. Three quotes will need to be obtained and then the council will be called for a decision. They suggested calling Mullins Heating and Cooling, Dale Spivey, and Jimmy Gordon.
