Police Report, Chief Terry Sivert

Water Plant Supervisor Report, Brian Bush

Mr. Bush reports 11.2million gallons of water produced, 5.8 million sold and 3.4million sold to Woodway. The average pump hours were 19. 48% water loss. Painting of the treatment tanks is under way. The annual drinking water report should be finished this week.
